




### **OVERVIEW**

Nigeria's 2nd Joint External Evaluation (JEE) process was conducted in two phases; a first phase of self-evaluation completed by the country with multisectoral engagement using the JEE 3.0 tool and a second phase of external evaluation by subject matter experts from the World Health Organization (WHO) and national observers to validate the country's self-evaluation data report.

The JEE 3.0 tool used for the evaluation exercise aided the categorisation of participating national health security stakeholders into 19 technical areas under the broad umbrella of **PREVENT**, **DETECT**, **RESPOND** and **IHR RELATED HAZARDS AND POINTS OF ENTRY AND BORDER HEALTH** core capacities.

The 19 technical areas were graded consensually and with provided evidence by the stakeholders using the indicators in the JEE 3.0 tool with the guide of the technical and contextual questions which are descriptive and qualitative. These indicators have attributes that reflect various levels of capacity identified with a "1" - "5" score-grading system interpreted as:

- 1. No capacity: Attributes of a capacity are not in place
- 2. Limited capacity: Attributes of a capacity are in the development stage i.e. implementation has started with some attributes achieved and others commenced
- 3. **Developed capacity:** Attributes of a capacity are in place; however, sustainability has not been ensured (such as through inclusion in the operational plan of the national health sector plan with a secure funding source).
- 4. **Demonstrated capacity:** Attributes are in place and sustainable for a few years and can be measured by the inclusion of attributes or IHR core capacities in the national health sector plan and a secure funding source.
- 5. **Sustainable capacity:** All attributes are functional and sustainable, and the country is supporting one or more other countries in their implementation. This is the highest level of the achievement of implementation of IHR core capacities.





### **SELF EVALUATION PHASE**

The self-evaluation phase of Nigeria's second Joint External Evaluation (JEE) of International Health Regulations (IHR) core capacities took place on the 24th-28th July, 2023 bringing together health security stakeholders across 20 Ministries, Departments and Agencies (MDAs) and 25 partner organisations. The self evaluation, facilitated by Mr Biodun Ogunniyi and Dr Mahmud Dalhat officially commenced with opening remarks by the Director General of the Nigeria Centre for Disease Control and Prevention (NCDC), Dr Ifedayo Adetifa. Goodwill messages were given by stakeholders from the Federal Ministry of Health, Federal Ministry of Agriculture and Rural Development, Federal Ministry of Environment, Nigeria Institute of Medical Research, World Bank, United Kingdom Health Security Agency (UKHSA), United States Agency for International Development, Africa Field Epidemiology Network-Nigeria (AFENET-Nigeria), World Health Organization (WHO) Nigeria, United States Centers for Disease Control and Prevention Nigeria (USCDC-Nigeria), and Food and Agriculture Organization.

An understanding of the JEE process was facilitated by Dr Lois Olajide, the Nigeria IHR coordination lead to familiarise the participants with Nigeria's JEE journey and what the entire process entails. Dr Mahmud Dalhat, NCDC and Dr Jenom Danjuma, Resolve to Save Lives led the familiarisation session of participants with the self assessment workbook, technical area groupings and expected roles of the facilitators.





A session was held for participants to understand the importance and whole process of the JEE facilitated by Nigeria's national IHR focal point, Dr Oyeladun Okunromade before a deep dive by technical area evaluations by stakeholders present.

























































### **EXTERNAL VALIDATION PHASE**

The external validation exercise took place on the 14th-18th August, 2023 in Abuja. The exercise brought together Nigeria's health security stakeholders, technical and implementing partners, external evaluators from WHO, national observers from within and outside Nigeria and members of the press for a transparent and in-depth evaluation exercise.

### **OPENING CEREMONY**

In his opening remarks, Dr Chukwuma Anyaike representing the Permanent Secretary, Federal Ministry of Health and Social Welfare (FMOH&SW), highlighted the importance of Nigeria's 2nd Joint External Evaluation in fortifying Nigeria's ability to safeguard the health and wellbeing of its citizens through the determination to enhance capabilities in disease surveillance, emergency response, points of entry and borders, laboratory system and workforce development. In the same vein, the Director General of the NCDC reinforced this by highlighting the unwavering commitment of the country to ensure that health security systems are agile, robust and responsive, leveraging on lessons learnt from Nigeria's response to various disease outbreaks and public health events.

### **CLOSING CEREMONY**

In conclusion of Nigeria's 2nd Joint External Evaluation, the summary of findings from the assessment of Nigeria's IHR core capacities and feedback from visits to selected sites were presented by Dr Hendrick Jan Ormel, the Senior Advisor of the WHO global JEE secretariat and the team lead of the WHO JEE mission to Nigeria. He also highlighted the overarching and impressive strengths possessed by the country as assessed by the external evaluators.

Using the JEE scorecard, the assessment scores of each technical area indicator and recommended priority actions were presented by the external evaluators technical area leads facilitated by Dr Hendrick Jan Ormel. At the closing ceremony, dignitaries in attendance were the Permanent Secretary of the FMOH&SW, Solicitor General and Permanent Secretary of Federal Ministry of Justice, the Executive Director of the National Veterinary Research Institute, Office of the National Security Adviser, Permanent Secretary of the Federal Ministry of Environment, World Health Organization Nigeria Representative, Country Director of the United States Centres for Disease Control Nigeria, World Bank representative, the registrar of the Medical Laboratory Science Council of Nigeria, and the Executive Director of the National Institute of Medical Research.

Through Nigeria's 2nd Joint External Evaluation, the country was able to:

- 1. Assess the status of implementation of health security capacities in Nigeria using a health security assessment tool 3.0
- 2. Measure the progress across 19 IHR core capacities to set new benchmarks for the development of implementation plans and roadmaps for action
- 3. Identify priority actions across various technical areas and use





the recommendations of the assessment to inform the development of National Action Plan for Health Security 2.0

4. Commence discussions, to inform resource mobilisation and preparedness planning for development partners

The outcome of assessing the nation's health security core capacities, using the JEE tool score-grade showed a total score of 54%. This was a 15% increase from the 1st JEE conducted in 2017.





### **MEDIA SUMMARY**

### TRADITIONAL MEDIA

The media plays a crucial role in amplifying the public health success stories and health-related information to the general public. Additionally, they play a crucial role in agenda-setting for health security.

The media coverage at Nigeria's 2nd Joint external evaluation was substantial and effective with over 42 on-site reporters from both international and national present at the event for the opening and closing ceremonies. This in turn made the evaluation workshop garner significant awareness. The published media articles mentioning the evaluation generated over 50+ articles worldwide. The coverage focused on the opening remarks, the JEE milestone, tools and the new score.

To ensure widespread dissemination and accurate coverage by the press official, a press release and an event brief was published and shared to the network of health journalists within the country of more than 1,500 journalists. The media presence played a crucial role in amplifying the impact and reach of Nigeria's 2nd JEE 2023.
