DATA AS REPORTED AND ACCURATE BY NCDC AS AT MIDNIGHT 5th JUNE 2020

HIGHLIGHTS

- Three hundred and twenty-eight (**328**) confirmed cases were reported in the last 24 hours in fourteen (**14**) states – Lagos (121), FCT (70), Bauchi (25), Rivers (18), Oyo (16), Kaduna (15), Gombe (14), Edo (13), Ogun (13), Jigawa (8), Enugu (6), Kano (5), Ondo (2) and Osun (2).
- No new state recorded a confirmed COVID-19 case in the last 24 hours. The total number of states including FCT that have reported at least one confirmed case in Nigeria is still **36** (35 states + FCT).
- One hundred and sixty-one (**161**) cases were discharged in the last 24 hours in ten (**10**) states – Katsina (62), Kano (23), Ogun (22), Edo (19), Oyo (14), Kaduna (8), Rivers (7), Enugu (2), FCT (2) and Plateau (2).
- Ten (**10**) deaths were recorded in the last 24 hours in five (**5**) states – Edo (5), Ondo (2), Kaduna (1), Ogun (1) and Rivers (1).

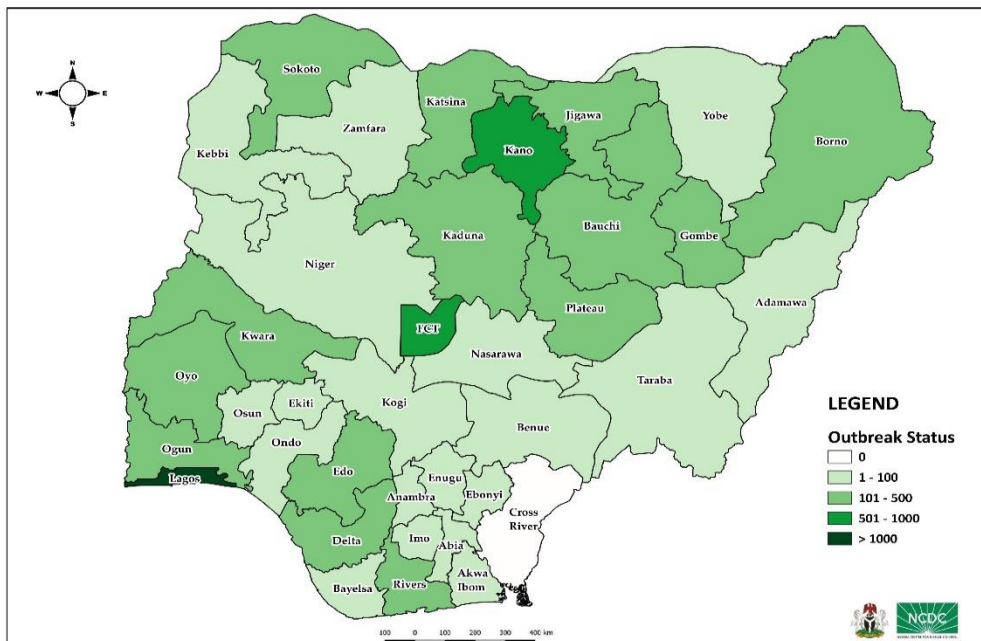

Figure 2: Daily Epidemic Curve of Confirmed Cases (WK9 – WK23)

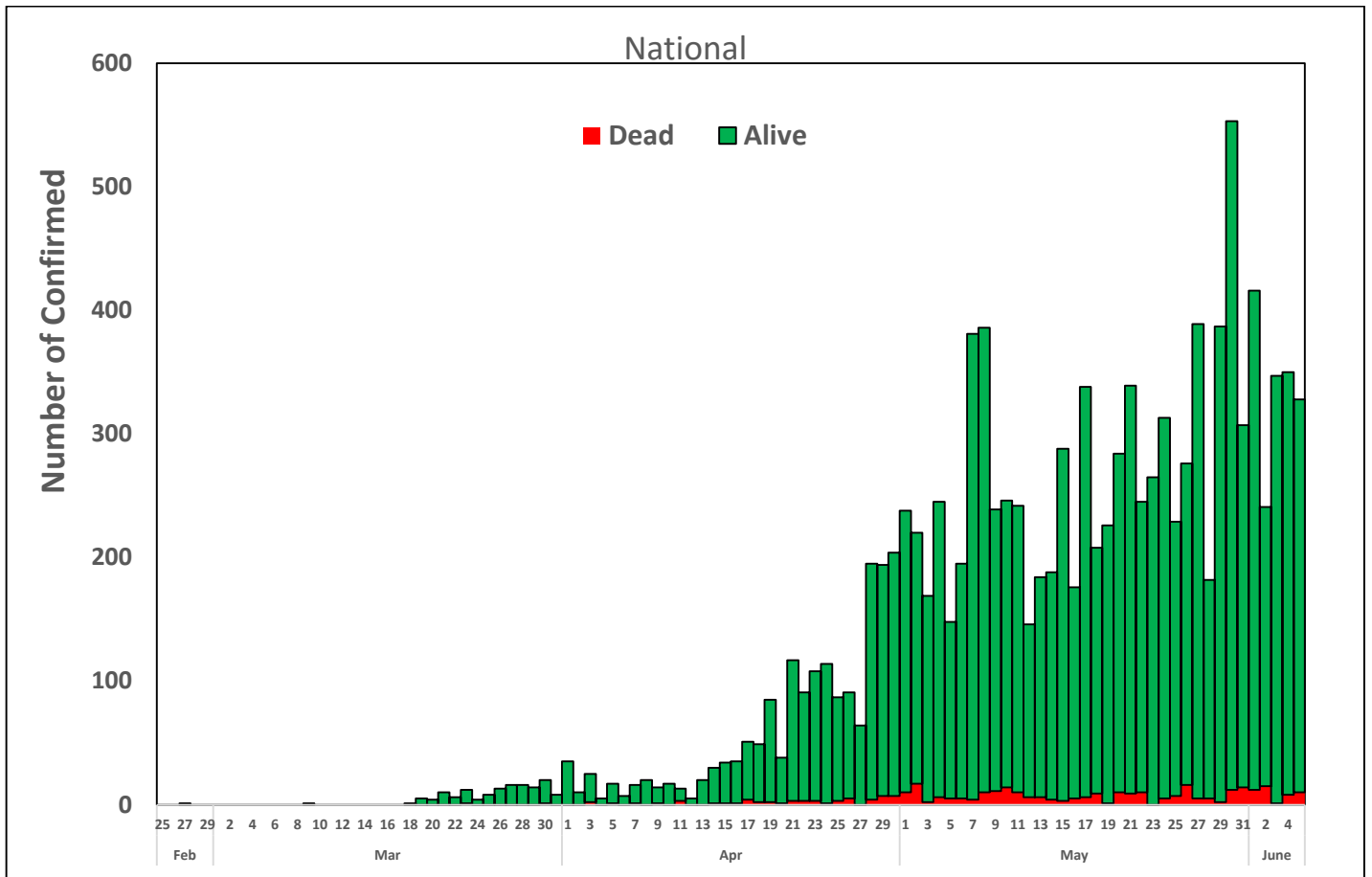
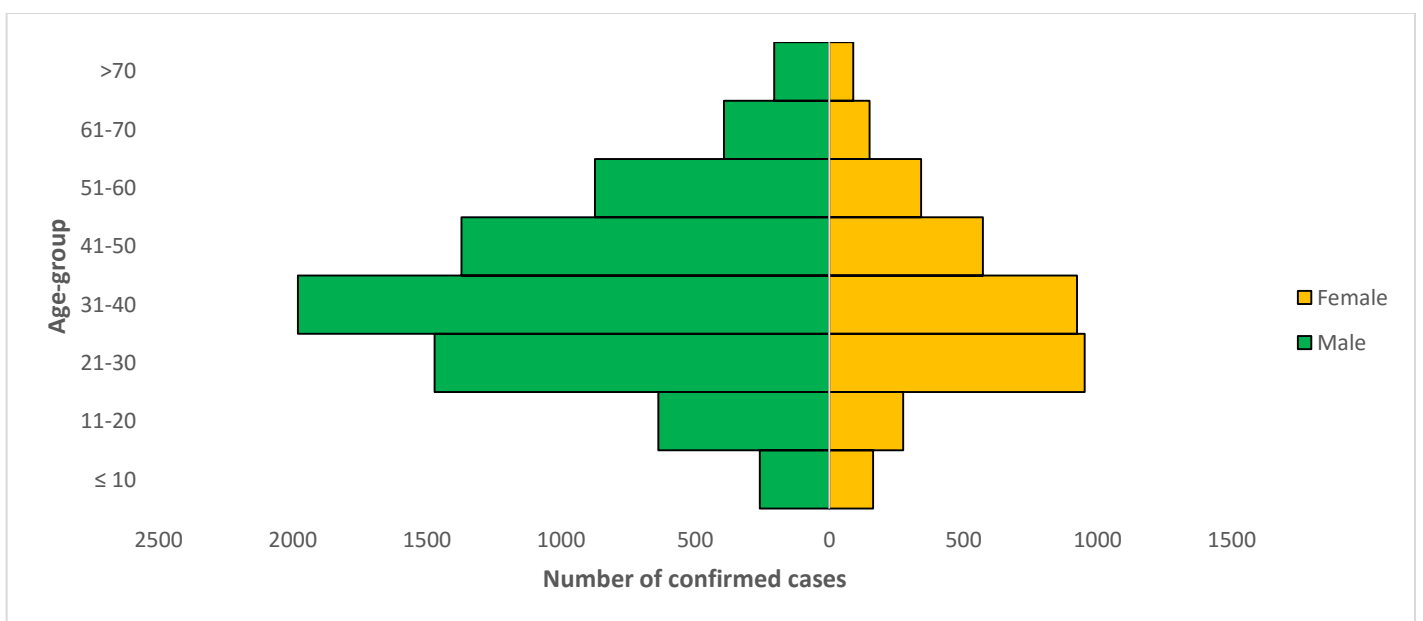


Figure 3: Age-Sex Distribution of Confirmed Cases (WK9 – WK23)



PREPAREDNESS

Since the confirmation of the first case on 27th February 2020, the NCDC has released advisories and statements to help Nigerians and affected groups in particular to respond to the pandemic

- NCDC and the Department of Hospital Services (Federal Ministry of Health) have updated the [case management guidelines](#) (version 3) with reviewed changes such as the discharge criteria and medication being used for the treatment of cases
- Guidelines have been issued for the [safe transportation of remains of persons suspected or confirmed to have died of COVID-19](#)
- Information on diagnostics of the COVID-19 virus can be found in our [detailed FAQ document](#).
- To increase our testing capacity, NCDC has issued guidelines for the [integration of private labs](#).
- Guidelines for [businesses and employers](#) have been updated.
- NCDC has updated its [case definition](#) , [community case definition](#) and [case management guide](#).
- NCDC releases periodic [public health advisories](#) to Nigerians on the COVID-19 disease.
- To adhere to post-lockdown measures, NCDC has released an [advisory on the use of face masks](#), as well as information on the [Use of Cloth face masks](#) and [how to make your cloth face masks](#).
- NCDC has released guidelines for the [management of pregnant women and nursing mothers](#) during the pandemic.
- To address burials of loved ones who die from COVID-19, guidelines have been issued to advise on the [management of dead bodies](#).

RESPONSE

On 28th February 2020, a multi-sectoral Emergency Operations Centre (EOC) was activated at Level 3 – the highest emergency level in Nigeria –led by NCDC in close coordination with the State Public Health EOCs (PHEOC).

- **High level strategic virtual engagement with 37 State Epidemiologists on new control measures to improve the current outbreak and shared update on the progress of the proposed NCDC/World Bank support**
- **Ongoing daily monitoring of 280 returnees/evacuees in Abuja**
- **Training of Healthcare Workers (HCWs) in hard to reach areas of Southern Borno**
- **Developed guidelines on safe event management**
- **Finalised national dialogue on schools` reopening with the education sector**
- **Completed onsite training on sample collection for 25 health workers in Ondo and Benue**
- Ongoing engagement with states to identify challenges in data management
- Commenced tracking of daily sample collection by States
- Trained 717 network staff of national disease programmes on IPC across various sessions in Lagos
- Supported the development of guidelines for the second phase of the ease of lockdown and opening of religious centres
- Ongoing planning for training of border communities in the Economic Countries of West Africa States (ECOWAS) region
- Produced additional jingles on asymptomatic nature of COVID-19 in English, Pidgin, Hausa, Igbo and Yoruba
- Ongoing finalisation of sample collection scale up strategy
