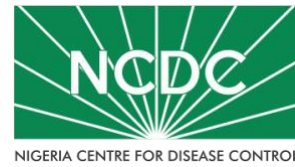


# COVID-19 SITUATION REPORT

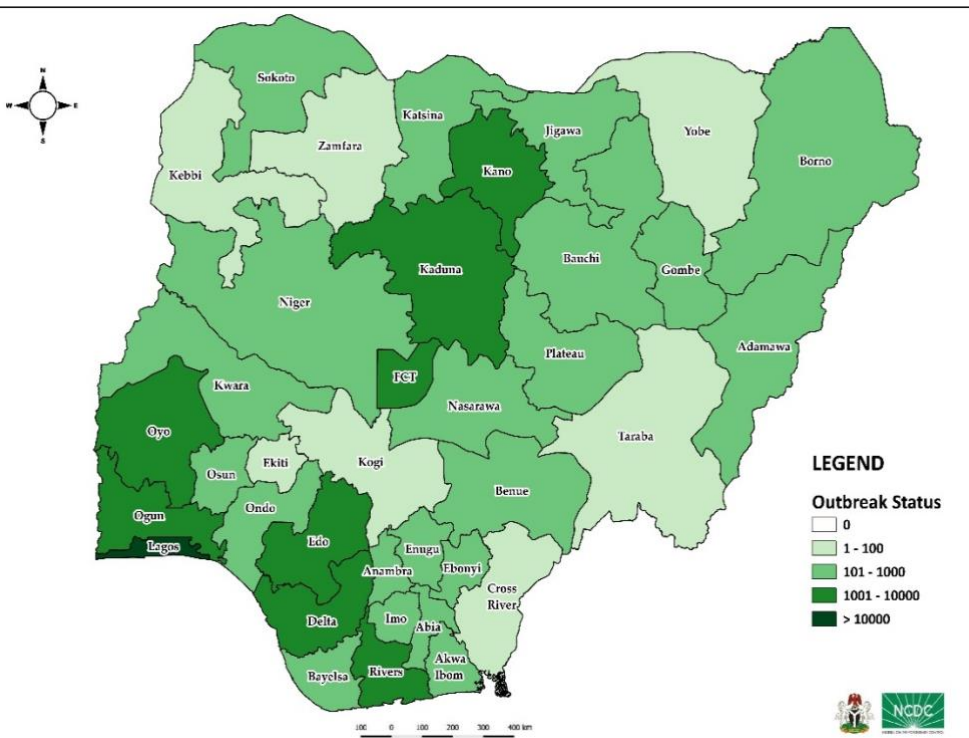
DATA AS REPORTED AND ACCURATE BY NCDC AS AT MIDNIGHT 21<sup>ST</sup> JULY 2020

### HIGHLIGHTS

- Five hundred and seventy-six (**576**) confirmed cases were reported in the last 24 hours from **22** states – Lagos (88), Kwara (87), FCT (82), Plateau (62), Ondo (39), Enugu (28), Oyo (26), Taraba (24), Ebonyi (20), Kaduna (20), Edo (17), Cross River (16), Kano (14), Rivers (11), Ogun (10), Delta (9), Nasarawa (8), Osun (8), Katsina (3), Imo (2), Borno (1) and Kebbi (1).
- Three hundred and forty-four (**344**) cases were discharged in the last 24 hours in **14** states – Kaduna (59), Osun (56), FCT (41), Plateau (37), Rivers (36), Lagos (29), Bayelsa (21), Edo (20), Ogun (14), Enugu (11), Borno (8), Delta (4), Imo (4), and Oyo (4).
- **Four** deaths were recorded in the last 24 hours in **three** states – Ebonyi (2), Ogun (1) and Lagos (1).
- All **36** states in Nigeria, and the FCT, have reported a confirmed case.

Figure 2: Daily Epidemic Curve of Confirmed Cases (WK9 – WK30)

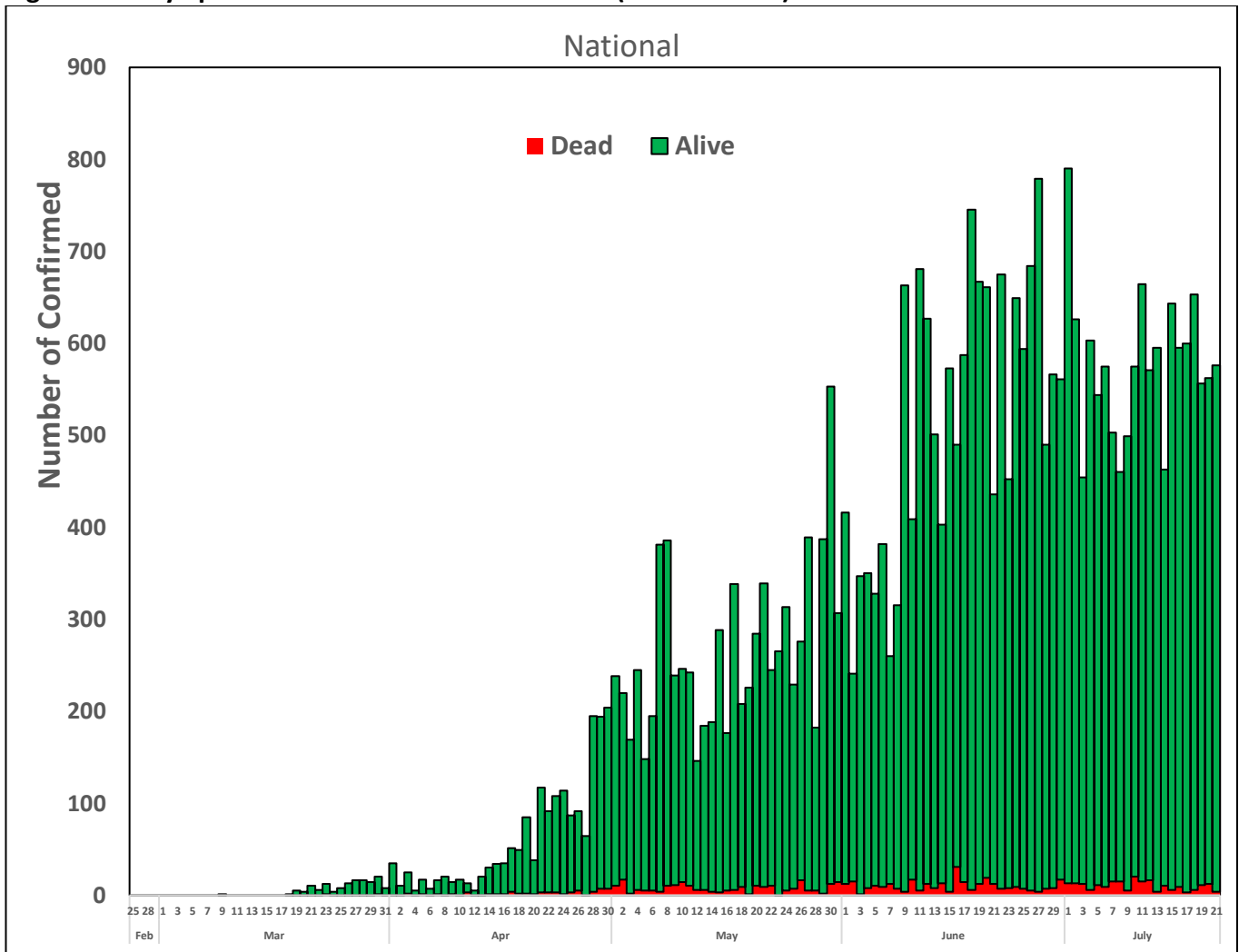
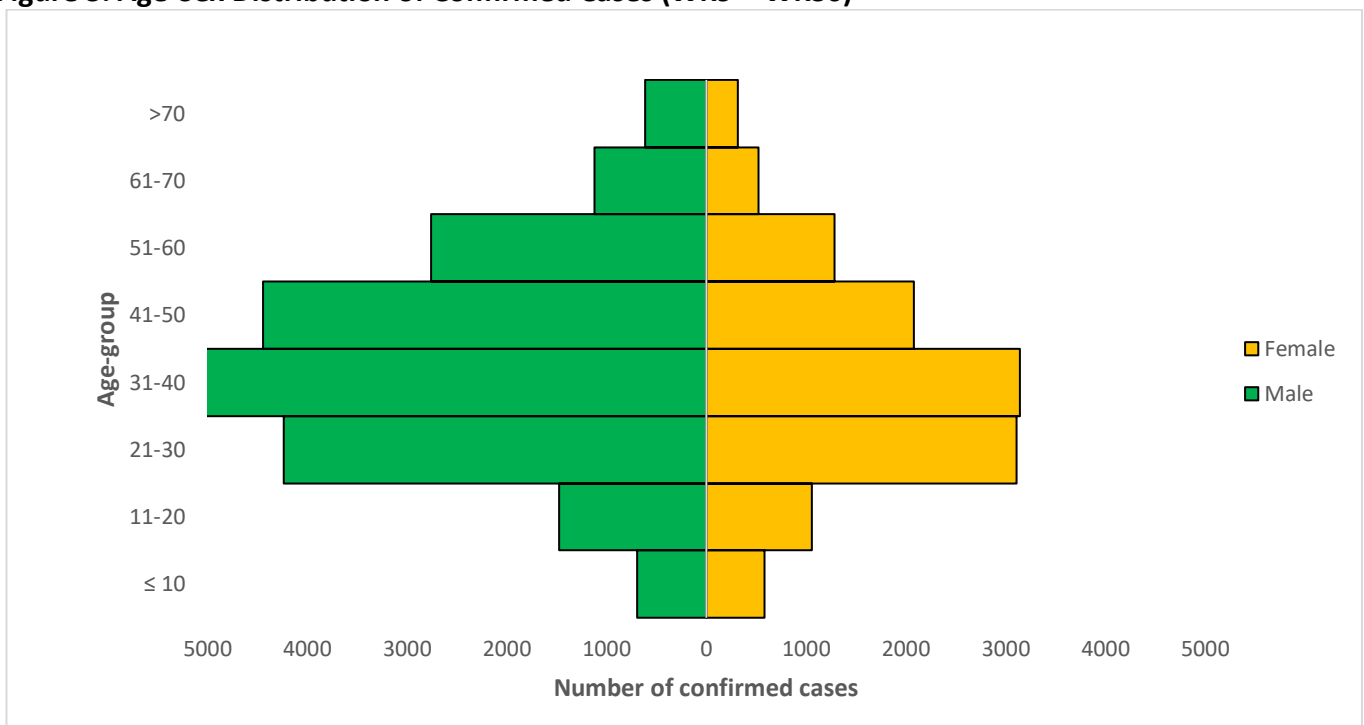


Figure 3: Age-Sex Distribution of Confirmed Cases (WK9 – WK30)



## PREPAREDNESS

Since the confirmation of the first case on 27<sup>th</sup> February 2020, the NCDC has released advisories and statements to help Nigerians and affected groups in particular to respond to the pandemic

- NCDC has launched an online course on [Infection, Prevention and Control \(IPC\) for COVID-19](#) NCDC eLearning platform
- Ahead of forthcoming elections in the country, NCDC has issued [Guidelines for Conducting Elections During the COVID-19 Outbreak in Nigeria](#).
- To protect our elders, and those with pre-existing medical conditions, NCDC has issued an [Advisory for Vulnerable Groups](#).
- NCDC has released [guidelines on the re-opening of places for worship](#).
- The Nigeria Police Force has released COVID-19 operational guidelines for the [Police and other Law Enforcement Agencies in Nigeria](#)
- NCDC and the Department of Hospital Services (Federal Ministry of Health) have updated the [case management guidelines](#) (version 3) with reviewed changes such as the discharge criteria and medication being used for the treatment of cases
- Guidelines have been issued for the [safe transportation of remains of persons suspected or confirmed to have died of COVID-19](#)

## RESPONSE

On 28<sup>th</sup> February 2020, a multi-sectoral Emergency Operations Centre (EOC) was activated at Level 3 – the highest emergency level in Nigeria –led by NCDC in close coordination with the State Public Health EOCs (PHEOC).

- **Commenced the first batch of states ‘Training of Trainers’ (TOT) on contact tracing and active case search with 12 states**
- **Developed surveillance research workplan**
- **Conducted training in sample collection and packaging in Cross River, Ebonyi and the FCT**
- **Organised training webinar for state focal persons on risk factors for healthcare workers in COVID-19 infection**
- **Commenced upload of laboratory data on the Logistics Information Management System (LOMIS)**
- **Shared targeted intervention template with trained participants from correctional facilities to understand their challenges**

- Conducted a virtual strategic coordination meeting with the national response team deployed to Kano State to improve current response efforts
- Monitoring of 8,214 Persons of Interest (POI)/returnees since 6<sup>th</sup> May 2020 in Lagos and Abuja with 6,264 tested out of which 509 were positive and 5755 negative as at 20th July 2020
- Conducted weekly data quality monitoring and tracking of improvements
- Conducted refresher training for Infection Prevention and Control (IPC) committee members in Ondo State
- Ongoing review of IPC guidelines on rational use of Personal Protective Equipment (PPE)
- Commenced additional deployment of response materials, laboratory supplies and commodities to states
- Finalised strategies to facilitate data utilisation report from states
- Developed advisory and jingle script for Salah celebration
